THIS AMENDMENT NO. 1 to ITB 2023-071 Agreement for Pressure Cleaning Services, by and between the City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Blue Edonis LLC, a Florida Limited Liability Company (hereinafter referred to as "Contractor"), whose address is 719 NE 83<sup>rd</sup> Ter #306, Miami, Florida 33138 is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2025.

WITNESSETH:

**WHEREAS**, on May 7, 2024, the City entered into a three (3) year agreement with Contractor for services (hereinafter referred to as the "Agreement") with two (2) one (1) year renewal options; and

**WHEREAS**, the City and the Contractor desire to amend the Agreement to increase the frequency of pressure cleaning services from twelve (12) times per year to twenty-four (24) times per year for Group A locations; therefore, pricing will increase from one hundred four thousand seven hundred and five (\$104,705) dollars to two hundred and nine thousand four hundred and ten (\$209,410) dollars per year; and

**WHEREAS**, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

**NOW, THEREFORE**, for and in consideration and other valuable consideration, the receipt and sufficiency where of are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. The Agreement is hereby amended to increase the frequency of pressure cleaning services to Group A locations, Group A locations and the Pricing Schedule to the Agreement, is hereby replaced with the attached Exhibit "A".
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
