

RESOLUTION NO. 83-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA APPROVING AN AGREEMENT WITH UNIFIRST CORPORATION FOR THE PURCHASE OF UNIFORMS AND RELATED PRODUCTS AND SERVICES UTILIZING SOURCEWELL RFP NO. 011124; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THIS AGREEMENT; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide products and services in accordance with its Charter; and

WHEREAS, Sourcewell administers a Cooperative Purchasing Program wherein it performs a solicitation for a multitude of products and administers the resulting contracts; and

WHEREAS, contracts solicited by Sourcewell are accessible to federal, state/province, and principal government entities, higher education, K-12 education, nonprofit, tribal government, other public entities located in the United States and Canada; and

WHEREAS, Sourcewell issued Request for Proposals (“RFP”) No. 011124 to obtain vendors for uniforms and other related products and services for itself and participating entities; and

WHEREAS, Unifirst Corporation (“Contractor”) was awarded one of the contracts pursuant to the solicitation; and

WHEREAS, the City desires to procure these uniforms and goods and services from Contractor, pursuant to Sourcewell RFP NO. 011124; and

WHEREAS, in accordance with Section 25 of the City’s Purchasing Policies and Procedures Manual, Piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Contractor, which is attached to this Resolution as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to execute any amendments and/or renewals and take any and all actions necessary to effectuate this Agreement.

Section 4. This Resolution shall become effective immediately upon its passage and adoption.
