**A**. Amendment to the Land Development Regulations, Private Parking Lot Signage (2023-116): Provide a recommendation to the City Commission on Ordinance No. 19-24, a City-initiated amendment to LDR Section 4.3.3, "Special requirements for specific uses" of the Land Development Regulations (LDR) to adopt regulations for private parking lots and garages.

# **Staff Presentation**

Anthea Gianniotes, Director of Development Services, presented the project from a Microsoft PowerPoint presentation.

#### **Board Comments**

Mr. Brown said that he was aware of some of the problems that arise with parking, and he had some suggestions to share. Mr. Brown said that in Pompano Beach one of the problems is that the parking lots copy the city citations; the same logo and font to make it look like it is from the city. In West Palm Beach the private lots must register with the city and pay an annual fee. They can't copy the citation; this is to prevent predatorial issues from the lot owners.

Ms. Mollica said that the citation would need to state that it is privately issued, not issued by government authorities, not subject to criminal penalties.

Ms. Gianniotes said on page 3 of the proposed ordinance, it explicitly prohibits the private provider from using the logo of the City of Delray Beach.

Ms. Mollica said that the State tells the private lot owners that they are supposed to provide all their rates.

Mr. Straghn asked if the State statute requires that the rate is displayed, or if this is what the city is proposing.

Ms. Thomas said there are many complaints about having to pay hundreds of dollars if a customer goes over their time. She said she is happy that this is being addressed to protect the constituents and visitors to the city.

Ms. Gianniotes said that the Historic Preservation Board requested that the signage is more standardized in historic districts.

**MOTION** to move a recommendation of approval of Ordinance No. 19-24, amending LDR Section 4.3.3, "Special requirements for specific uses" of the Land Development Regulations (LDR) to adopt Subsection (PP), "Private parking lots and garages," with regulations governing such use, finding that the amendment and approval thereof is consistent with the Comprehensive Plan and meets the applicable criteria set forth in the Land Development Regulations was made by Judy Mollica and seconded by Dedrick Straghn.
