A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH BOUND TREE MEDICAL, LLC FOR EMS MEDICAL SUPPLIES UTILIZING BREVARD COUNTY INVITATION TO BID B-7-23-56; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide services and products in accordance with its Charter; and

WHEREAS, the City requires EMS medical supplies; and

WHEREAS, Brevard County, Florida issued Invitation to Bid ("ITB") B-7-23-56 to obtain EMS medical supplies; and

WHEREAS, Bound Tree Medical, LLC ("Contractor") is one of Brevard County's awarded vendors for the purchase of EMS medical supplies; and

WHEREAS, the City desires to obtain these aforementioned supplies by utilizing the pricing provided to Brevard County pursuant to ITB B-7-23-56; and

WHEREAS, in accordance with Section 25 of the City's Purchasing Policies and Procedures Manual, Piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City desires to enter into an agreement with Contractor, as a Piggyback, to obtain the aforementioned goods and services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:
