NOTICE OF PUBLIC HEARING

To be Held

AT DELRAY BEACH CITY HALL

The City Commission of the City of Delray Beach will hold a public hearing to adopt a non-ad valorem assessment roll for annual stormwater management assessments. This public hearing will be held on August 12th, 2025, at 5:00 p.m. in the City Commission Chambers at City Hall, located at 100 N.W. 1st Avenue, Delray Beach. This assessment will be imposed on all non-exempt property owners within the City of Delray Beach (geographic depiction below).



Residential property owners with less than 10,000 square feet of impervious coverage area will be assigned to one of the four tiers listed below. Residential properties with more than 10,000 square feet of impervious coverage area will be charged based upon their actual impervious area. Non-residential properties will continue to be billed based upon their actual impervious area utilizing the Stormwater Billing Unit (SWU). Unimproved land (any lot with less than 500sq ft impervious) is assigned one (1) SWU. The assessment is proposed at the rate of \$1.93 per month per SWU, for a total annual assessment of \$23.17 per SWU. This represents an increase of \$9.73 in comparison to the previous year.

All funds from the assessments will be used to operate, maintain, make additions, improvements, and extensions to the City's Stormwater Management System. Additionally, these funds will be used to finance the administration of the program. The stormwater management assessments will be included on the 2026 property tax bills issued to property owners in November. These funds will be collected by the Palm Beach County Tax Collector. All affected property owners have the right to appear at the public hearing and the right to file written objections within twenty (20) days of this notice.

Please be advised that if a person decides to appeal any decision made by the City Commission with respect to any matter considered at this hearing, such person will need a record of the proceedings and for this purpose such person may need to ensure that a verbatim record includes the testimony and evidence upon which the appeal is to be based. The City does not provide nor prepare such record. Pursuant to F.S. 286.0105.
