Rebekah Dasari, Principal Planner, presented the project from a Microsoft PowerPoint presentation.

Ms. Mollica was in favor of the signage promoting schools.

Mr. Straghn asked for clarification as to what the business would be allowed to put on the bus shelter.

Mr. Brown said that he supports what the other board members decide.

Mr. Katz asked how the logos from the different types of businesses would be regulated and Ms. Vega responded that it would be approved by the City Manager. Mr. Katz said

that he cannot support the amendment because of the lack of ability to control signage content.

Judy Mollica asked in the sign code if exempt signs could pertain to Mr. Katz's concern. Ms. Dasari said that this would fall under the category of sponsorship signs.

Mr. Straghn asked if this would be different than the sponsorship signs that are near Atlantic High School where there are sponsorship banners. Ms. Vega said that the city will put in safeguards.

Mr. Meiselman asked what the dollar amount is for the sponsorship and how many signs there would be. Kate Johnsons, Secretary of Delray Chamber Education Fund, President of the Delray Chamber of Commerce, said that this program had raised over \$48,000 since it began and \$30,000 has gone back to schools. It is reviewed by DCEF, and by the City for approval of the sign image.

Mr. Snyder commented that if there were inappropriate signs then the program would be shut down.

MOTION to Recommend approval to the City Commission of Ordinance No. 36-24, a City-initiated amendment to Section 4.6.7, "Signs" of the Land Development Regulations (LDR) to adopt regulations for bus shelter sponsorship signage, finding that the amendment and approval thereof is consistent with the Comprehensive Plan and meets the criteria set forth in Land Development Regulations made by Judy Mollica and seconded by Chris Brown
