

## AGREEMENT

**THIS AGREEMENT** is hereby made and entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_, (the “effective date”) by and between the City of Delray Beach, a Florida municipal corporation (“City”), whose address is 100 N.W. 1<sup>st</sup> Avenue, Delray Beach, Florida 33444, and Florida CDI, LLC, a Florida Company, (hereafter referred to as “Contractor”), whose address is 3124 NW 16<sup>th</sup> Terrace, Pompano Beach, FL 33064.

**WHEREAS**, the City desires to retain the services of the Contractor to assembly, disassembly, maintenance, repair, and transportation of the City’s 100’ Aluminum Tree in addition to the 9-North Pole Village Structures in accordance with the City’s Invitation to Bid Construction No. 2020-033, and the Contractor’s response thereto, all of which are incorporated herein by reference.

**NOW, THEREFORE**, in consideration of the mutual covenants and promises hereafter set forth, the Contractor and the City agree as follows:

### ARTICLE 1. INCORPORATION OF INVITATION TO BID CONSTRUCTION

The terms and conditions of this Agreement shall include and incorporate the terms, conditions, and specifications set forth in the City’s Invitation to Bid Construction No. 2020-033, and the Contractor’s response to the Invitation to Bid Construction, including all documentation required thereunder.

### ARTICLE 2. DESCRIPTION OF GOODS OR SCOPE OF SERVICES

The Contractor shall assemble, disassemble, maintain, repair, and transport the City’s 100’ Aluminum Tree in addition to the 9-North Pole Village Structures pursuant to the specifications accompanying the City’s Invitation to Bid Construction, which are incorporated herein by reference.

### ARTICLE 3. COMPENSATION

The City shall pay to the Contractor, in compliance with the Pricing Schedule attached hereto and incorporated herein, according to the terms and specifications of the referenced Invitation to Bid Construction.

### ARTICLE 4. MISCELLANEOUS PROVISIONS

a. Notice Format. All notices or other written communications required, contemplated, or permitted under this Agreement shall be in writing and shall be hand delivered, telecommunicated, or mailed by registered or certified mail (postage prepaid), return receipt requested, to the following addresses:

b. Headings. The headings contained in this Agreement are for convenience of reference only, and shall not limit or otherwise affect in any way the meaning or interpretation of this Agreement.

c. Effective Date. The effective date of this Agreement shall be as of the date it has been executed by both the parties hereto.

#### ARTICLE 5. CONTRACT TERM

This term of this Agreement shall commence upon the date of the duly executed Agreement and shall remain in effect for a term of five years, unless terminated earlier in accordance with terms set forth in the ITB. Upon mutual agreement of the City and the Contractor, the Agreement may be renewed for up to five additional years.
