THIS AMENDMENT NO. 2 to City-Wide Management Services dated June 6, 2017 by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as “City”), and CDM Smith Inc. **WHEREAS**, on June 6, 2017, the City entered into a one (1) year agreement with four (4) renewal options with Second Party for project management services (hereinafter referred to as the “Agreement”); and

**WHEREAS**, in May 15, 2018, the City exercised a one (1) year option to renew the Agreement through June 5, 2019; and

**WHEREAS**, the City determines that it is in its best interest to exercise its second one (1)-year option to renew the Agreement through June 5, 2020, in accordance with the terms and conditions of the Agreement; and

**WHEREAS**, Second Party agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 2 extends the Agreement, under the same terms and conditions, for the period of June 6, 2019 through June 5, 2020.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
