Johnson is re-elected as Commission Member/Seat #4 for three year terms commencing on the 31st day of March, 2020, and ending in accordance with the Charter. Also, the results of the referendum question posed to Delray Beach voters as to whether the Charter Amendment should be adopted for salary increases of the Mayor and Commissioners each year.

that Juli Casale is elected as Commission Member/Seat #2 and Shirley E. Johnson is re-elected as Commission Member/Seat #4 for three year terms commencing on the 31st day of March, 2020, and ending in accordance with the Charter.

No - 7,127 votes


