RESOLUTION 2024-19 - APPROVE A PURCHASE AND SALE AGREEMENT WITH ROSE M. STEPHENS FOR THE PURCHASE OF THE PROPERTY LOCATED NEAR NW 7<sup>th</sup> AVENUE - PCN 12-43-46-16-01-012-0080

# **Recommended Action:**

1. Approve a Purchase and Sale Agreement with Rose M. Stephens for the purchase of a property located near NW 7<sup>th</sup> Avenue (PCN 12-43-46-16-01-012-0080) (Subject Property) for a purchase price of \$305,000, in a form legally acceptable to the CRA Legal Counsel;

## AND

2. Authorize the CRA Board Chair to execute the Purchase and Sale Agreement, and any related documents, in a form legally acceptable to the CRA Legal Counsel.

# **Background:**

The Subject Property is located near NW 7<sup>th</sup> Avenue, Delray Beach, Florida, within the Northwest Neighborhood of The Set (CRA District Sub- Area 3). The Subject Property comprises approximately 4,875 sq. ft. and is zoned Central Business District.

The Seller has agreed to a purchase price of \$305,000 for the Subject Property.

Purchasing the Subject Property assists the CRA's mixed use/ workforce townhouse redevelopment project planned for the NW 600 Block of West Atlantic Avenue that is currently in the design phase. The addition of the Subject Property would improve design plans and allow for the development of additional workforce housing units.

At this time, CRA staff is requesting the CRA Board:

1. Approve a Purchase and Sale Agreement with Rose M. Stephens for the property located near NW 7<sup>th</sup> Avenue (PCN 12-43-46-16-01-012-0080) for a purchase price of \$305,000 in a form legally acceptable to the CRA Legal Counsel;

#### AND

2. Authorize the CRA Board Chair to execute the Purchase and Sale Agreement, and any related documents, in a form legally acceptable to the CRA Legal Counsel.
