Hello Renee.

We appreciate the situation for the greenmarket. However this is 1 day out of the year and this is a huge charitable event and it is extremely important to us to have the additional participation of the front lawn for the 5th Annual, which will generate additional revenues for our goals to contribute to Delray first responder and children charities.

We are sorry we are unable to accommodate the greenmarket on the front lawn. We share the CRA organization's mission of maximizing local economic impact for Delray constituents, including tax-paying merchants in the CRA district, which our International Concours has demonstrated has great impact.

It would be worth our board's reconsideration to our cancellation request if you agreed in writing to the following prior to Friday August 22nd. If you can guarantee the relocation, without any CRA, City, waste management, or additional cost or hindrance to our charitable event, of the April 18th greenmarket to across (West of) Swinton Avenue, then yes we will reconsider. We would not block access to your dumpster by your staff (but no greenmarket vendors or their vehicles are permitted in our event footprint) if you agreed to transport trash across the street (or move the dumpster to your relocation at your cost).

Our board is scheduled to attend the August 28th CRA board meeting. Otherwise our impact event permit and national corporate event partners cannot afford further delays. We have already added a 5th month to the permit process due to the CRA public comment process.
