AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING CHAPTER 122, "ADDITIONAL HOMESTEAD EXEMPTION FOR PERSONS 65 YEARS AND OLDER", OF THE CODE OF ORDINANCES OF THE CITY OF DELRAY BEACH, SECTION 122.01, "ADDITIONAL HOMESTEAD EXEMPTION FOR PERSONS 65 YEARS OF AGE AND OLDER," TO INCREASE THE ADDITIONAL HOMESTEAD EXEMPTION FROM \$25,000 TO \$50,000 FOR CERTAIN PERSONS SIXTY-FIVE (65) YEARS OF AGE AND OLDER AND TO ESTABLISH A SECOND ADDITIONAL HOMESTEAD EXEMPTION IN THE AMOUNT OF THE ASSESED VALUE OF PROPERTY FOR CERTAIN PERSONS SIXTY-FIVE YEARS OF AGE AND OLDER WHO MEET RESIDENCY, INCOME AND OTHER STATUTORY REQUIREMENTS; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

- b. Per FS 196.075 to increase the previously adopted additional homestead exemption for certain person 65 years of age and older from \$25,000 to \$50,000;
- c. To authorize a second, additional homestead exemption in the amount of the assessed value of property for certain persons 65 years of age and older who meet specific residency, income, and other statutory requirements.

In accordance with the provisions of controlling law, the City of Delray Beach hereby publishes the following information:

The Proposed ordinance will provide additional homestead exemption for persons 65 years of age and older, to increase the additional homestead exemption from \$25,000 to \$50,000 and to establish a second homestead exemption in the amount of the of the assessed value of property for certain persons sixty-five of age and older who meet residency, income, and statutory requirements.
