Jani Bowens, Education, and External Operations Manager, provided the historical context of the Caron Foundation Settlement. She stated in 2018, a Life Skills and Drug Prevention Grant using Caron Funds was implemented in the Neighborhood and Community Services Department under the previous Director and Education Coordinator, and a total of fourteen(14) grants were provided to nonprofits in total. Ms. Bowens stated in 2023, she received direction from the Commission to help address systems affecting student performance. In February 2024, the Commission approved funding agreements for seven (7) Delray Beach Public Schools to support programming in critical areas, which aligned with the Delray Beach Comprehensive Plan. She reported the estimated Caron Foundation Settlement, Inc. fund balance is \$1,064,000, and this money would be used to support the original intent of the grant.

The Commission engaged in a discussion on the presentation regarding the expectations for external partnerships. They acknowledged that the School was expecting the funds this year, but the City could seek nonprofits that impact student performance, mental health awareness, and behavior to allocate funding to in the future.
