AN ORDINANCE OF THE CITY COMMIS-SION OF THE CITY OF DELRAY BEACH. FLORIDA, AMENDING THE CODE OF ORDI-NANCES, TITLE 5, "PUBLIC WORKS," CHAP-TER 56, "STORMWATER," "SECTION 56.02, "SCOPE AND PURPOSE," TO CLARIFY THE REFERENCE TO THE SYSTEM; AMENDING SECTION 56.04, "DEFINITIONS," AMEND-ING THE DEFINITIONS FOR COMMON ELEMENT, NONASSESSED PROPERTY, STORMWATER MANAGEMENT ASSESS-MENT, AND UNIMPROVED LAND, AND ADOPTING DEFINITIONS FOR CONDOMINI-UM PROPERTY, CONDOMINIUM UNIT, AND COOPERATIVE, TO EXPAND DEFINITIONS AND CLARIFY ASSESSMENT METHOD.
