A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH ROADWAY MANAGEMENT TECHNOLOGIES, LLC FOR SURVEYING SOFTWARE LICENSE AND SERVICES FOR **ROADWAY ANALYSIS PURSUANT** TO Α **SOLE** THE SOURCE DETERMINATION: **AUTHORIZING CITY** MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND **ALL** ACTIONS NECESSARY TO **EFFECTUATE** THIS AGREEMENT: PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (City) is authorized to enter into agreements to provide services, and products in accordance with its Charter; and

WHEREAS, the City requires surveying software license and services for roadway analysis; and

WHEREAS, Roadway Management Technologies, LLC, is the owner and manufacturer for the required platform; and

WHEREAS, on October 10, 202, Roadway Management Technologies, LLC, was approved as a Sole Source pursuant to the City's Purchasing Policies and Procedures Manual for the acquisition of surveying software license and services for roadway analysis; and

WHEREAS, the City desires to enter into a sole source agreement with Roadway Management Technologies, LLC for surveying software license and services for roadway analysis; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- Section 1. The foregoing recitals are hereby affirmed and ratified.
- <u>Section 2.</u> The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Roadway management Technologies LLC, to acquire surveying software license and services for roadway analysis utilizing the approved sole source; attached to this Resolution as Exhibit "A".
- <u>Section 3.</u> The City Commission authorizes the City Manager to execute any amendments and/or renewals to take any and all actions necessary to effectuate this Agreement.
