Attorney Brooke Ehrlich, with Ehrlich Law Firm, presented her findings to the Commission on the Special Investigator's Report. Her firm was tasked with investigating Fire Chief Keith Tomey's allegations against City Manager Terrence Moore.

After a comprehensive review of the allegations and conducting numerous interviews, Ms. Ehrlich concluded that the harassment allegation against Mr. Moore was not sustained. The remaining allegations were unable to be substantiated. She stated this conclusion was reached after a meticulous and unbiased investigation.

A motion was made by Vice Mayor Casale, seconded by Commissioner Burns, to accept to results of the Special Investigation.

The motion carried by the following:

There being no further business to discuss, Mayor Carney adjourned the meeting at 2:07 p.m.
