FISCAL YEAR 2023-2024 FUNDING INCENTIVE PROGRAMS FINAL SUMMARY

At the September 28, 2023, CRA Board meeting, the CRA Board approved the budget for Fiscal Year 2023-2024 that included \$600,000 for CRA Grant Funding Assistance and \$600,000 for the Curb Appeal Residential Improvement Program.

Site Development Funding Assistance Program

- **Jerk & Lime at Nicole's House, LLC (doing business as Nicole's House) (182 NW 5 Avenue, CRA Sub-Area #3)**

A **\$68,416** award was approved on January 24, 2023. Reimbursements totaling \$51,312 have been made (\$17,104 is withheld until project completion). The grantee was granted an extension due to delays in delivery of certain materials to February 29, 2024. At the time of the grant termination date, a CO was not received and the \$17,104 was not disbursed.

A **\$32,141** award was approved on November 16, 2023. An amendment was approved by the CRA Board on April 23, 2024, extending the termination date of the funding agreement to July 1, 2024. On the July 23, 2024, the CRA Board approved to extend the termination date to September 1, 2024. On September 24, 2024, CRA Board agenda to extend the termination date to October 31, 2024, and increase the award amount to \$39,671.25.
