Background:

The Fleet Division of the Public Works Department (Fleet Maintenance) has a responsibility to maintain the City of Delray Beach's (City) fleet of Pierce Manufacturing Inc. (Pierce) vehicles (fire apparatus). Pierce qualifies and designates specific dealers for different regions throughout the United States for factory-authorized parts, services, and the purchase of Pierce vehicles. The designated Pierce dealer for the City's region is Ten-8 Fire & Safety, LLC (Ten-8). Fleet Maintenance requests approval to designate Ten-8 as the sole source provider for Pierce Original Equipment Manufacturer (OEM) parts, related services, and vehicles.

Justification:

The City must utilize Pierce OEM parts and related services to preserve the warranties on such vehicles. The City's Pierce vehicles and equipment must be properly maintained to remain in service to provide world-class service to its citizens and visitors. This equipment is only authorized to be sold and serviced through authorized dealers that are trained and designated by Pierce.

Pierce's website has a dealer locator feature that shows the authorized Pierce dealers and service centers for each region. Ten-8 is the sole Pierce dealer and service center for the zip code 33444. Pierce customer service also referred the City to Ten-8 as the exclusive dealer.
