This Service Authorization, when executed, shall be incorporated in and shall become an integral part of the Contract, dated March, 2012 between the City of Delray Beach and Walters Zackria Associates, PLLC

I. PROJECT DESCRIPTION

City of Delray Beach would like to replace the existing Fire Station #3 Building located at 651 Linton Blvd., Delray Beach, FL 33483. Scope of work will include:

- 1. Full building and site demolition
- 2. New Fire Station Building, Site Upgrades, and Signalization on Linton Blvd.

II. SCOPE OF SERVICES

The following scope of services is developed in accordance with the Standard Agreement for Architectural Services.

Task 1 - Material Review and Needs Assessment

WZA shall review available material provided by City, including site survey(s), previous studies and technical and environmental reports, existing building plans and existing site conditions. Consultant will interview the appropriate City staff to gather current and future needs regarding the Facility.

Task 2 - Building Program

Based on the Material Review and Needs Assessment, the Consultant will prepare a building program. Program will convert the City's needs into building areas with approximate spatial size, adjacency relationships, equipment requirements, occupancy requirements, and programmatic considerations, etc. The Consultant shall provide a draft building program report to the City. The City will review and provide comments on the draft report, and the Consultant shall address City comments and produce a final building program report.

Deliverables: The Consultant shall provide a draft building program report and a final building program report.

Task 3 – Conceptual Building Plans

Based on the final building program report, Consultant will prepare a draft conceptual building plans illustrating a layout for the proposed Facility. Consultant will present the conceptual layout to City staff for discussion. The City will review and provide comments on the draft conceptual building plan, and the Consultant shall address City comments and produce a final conceptual building plan. Conceptual building plans will include a 2-story station design.

Deliverables: The Consultant shall provide a (1) draft conceptual building plans and (1) final conceptual building plans.

Task 4 – Conceptual Building Elevations

Consultant will prepare a draft conceptual building elevations. Consultant will present the conceptual elevations to City staff for discussion. The City will review and provide comments on the draft conceptual elevations, and the Consultant shall address City comments and produce final elevations. Conceptual building elevations will include a 2-story station design.

Deliverables: The Consultant shall provide a (1) draft conceptual building elevations and (1) final conceptual building elevations.

Task 5 – Conceptual Site Plan

In conjunction with the conceptual building plan, Consultant will prepare a conceptual site plan illustrating a layout for the proposed buildings and circulation walkways. Consultant will present the conceptual site plan to City staff for discussion. The City will review and provide comments on the draft conceptual site plan, and the Consultant shall address City comments and produce final site conceptual plan.

Deliverables: The Consultant shall provide (1) draft conceptual site plan and (1) final conceptual site plan.

Design Exclusions:

Design Development Documents, Colored Plans and Renderings, Site Plan Approval (SPRAB), Construction Document Preparation, Permitting, Bidding, Construction Phase Services and LEED Design Services are excluded from the scope of this Service Authorization.

- 4. City will provide a Current Cad Site Survey before Consultant begins Task 3.
- 5. City will provide Soil Borings.
- 6. City will provide Asbestos Survey.

This Service Authorization is approved contingent upon the City's acceptance of and satisfaction with the completion of the services rendered in the previous phase or as encompassed by the previous service authorization. If the City in its sole discretion is unsatisfied with the services provided in the previous phase or service authorization, the City may terminate the contract without incurring any further liability. The CONSULTANT shall commence work on any service authorization approved by the City to be included as part of the contract without a further notice to proceed.
