

RESOLUTION NO. 85-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH SUMIG DISTRIBUTION, LLC, FOR HEAVY EQUIPMENT PARTS AND SERVICES UTILIZING MARTIN COUNTY, FLORIDA, REQUEST FOR BIDS 2023-3467; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (“City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires parts and services for heavy equipment; and

WHEREAS, Martin County, Florida, issued Request for Bid (“RFB”) No. 2023-3467 to obtain heavy equipment parts and services; and

WHEREAS, in accordance with RFB No. 2023-3467, Martin County, Florida entered into an agreement with Sumig Distribution, LLC (“Contractor”); and

WHEREAS, the City desires to procure heavy equipment parts and services from Contractor utilizing the existing Martin County, Florida, agreement entered into pursuant to RFB No. 2023-3467; and

WHEREAS, in accordance with Section 25 of the City’s Purchasing Policies and Procedures Manual, Piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City desires to enter into an agreement with Contractor, as a Piggyback (“Agreement”), to obtain heavy equipment parts and services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to execute any amendments and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
