Isaac-

I reviewed the rezoning file, site plan file, ordinance, traffic study (performed by TrafTec), notations on the site plan, suggested conditions in the SPRAB staff report, and the PBC Traffic Division comments dated Feb 13, 2013. Here is what I found:

- 1. Ordinance 41-12 includes specific language that certain delivery vehicle types are prohibited from making SB US 1 U-turns toward NB US1. There is no mention of placing signage that would include such a restriction (see top of page 4 of the ordinance).
- 2. The traffic study was silent (no mention) of any restricted turning movements or signage.

- 3. PBC Traffic review made a "suggestion" that an exclusive NB right-turn lane onto the project main access driveway on US-1 be provided. No mention of restricting U-turns (see attached).
- 4. Page 40 of the SPRAB staff report includes condition #14 that states "If approved by FDOT, a no u-turn sign shall be placed at the intersection of Federal Highway and Tropic Isle Boulevard" (attached).
- 5. The approved certified plan includes a clouded-in notation near the intersection of Tropic Isle Blvd and US-1 that states "NO U-TURN" (R3-4, 24" X 24") CENTERED IN MEDIAN AT TROPIC ISLE BOULEVARD (see attached).

There was no mention of a U-turn restriction at the stated intersection in the TrafTec traffic analysis. Further, it would appear that general restriction of U-Turns was not applied; but was instead applied only to certain vehicle types. It is curious if FDOT ever approved the restricted turning movement. Hope this helps; discuss if necessary.
