THIS AMENDMENT NO. 1 to Property & Casualty Third Party Claims Administrator dated September 20, 2016, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Preferred Governmental Claim Solutions (Second Party), a Florida corporation authorized to do business in the State of Florida, is entered into this ____ day of _____, 20__.

WITNESSETH:

WHEREAS, on September 20, 2016 the City entered into a 3 year agreement with Preferred Governmental Claim Solutions for Property & Casualty Third Party Claims Administrator services;

WHEREAS, the City desires to continue to procure these services from the Second Party by exercising the first one-year option to renew the Agreement through September 19, 2020.

WHEREAS, Second Party agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 extends the Agreement, under the same terms and conditions, for the period of September 20, 2019 through September 19, 2020 for an annual not-to-exceed amount of One Hundred Thousand and Twenty /100 Dollars (\$120,000).
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement, and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
