- A preliminary detail of the actual administrative and investment-related expenses October 1, 2023 – September 30, 2024 and detail of the actual administrative and investment-related expenses October 1, 2024 – November 13, 2024 follows. (#1)
- 2) The City's contribution of \$3,023,430 was deposited on October 1, 2024. Salem Trust left the funds in the Receipts and Disbursements account as per the Committee's directive (#2).
- 3) A proposed 2025 Retirement Committee meeting schedule is included <u>for</u> <u>discussion and adoption</u>. (#3)
- 4) In each of the past several years, the Retirement Committee has authorized payout in December 75% of the immediately preceding March 31 Administrative Allowance Account ("AAA") balance to participants in the DROP on the date of distribution. The AAA balance on March 31, 2024 was \$2,792.84, 75% of which is \$2,094.63. Does the Committee authorize payout in December 2024 \$2,094.63 to those participants in the DROP on the date of the distribution? *For discussion and adoption*. (#4)
- 5) Due to the typical heavy January workload the Pension office experiences each year, we would like to mail the annual benefit verification ("alive & well") letters in late May/early June each year starting in 2025. *For discussion*.
