### Fee Proposal

The fee proposal is time and materials, at a flat rate of \$135 per hour for all listed services in the Scope of Services. The flat rate simplifies invoicing because a single resource is required to do work at many different levels of GIS expertise. Flipsidegeo's fixed, hourly rate is an average of these roles and allows the resource to be flexible and respond to whatever is the current task at hand without unnecessary limitations. All work will be directed by the City of Delray Beach Assistant IT Manager and administered by the City of Delray Beach GIS Manager.
