Mr. Moore informed the Commission that the Human Resources Department notified him that only one candidate was currently interested in applying for the internal auditor's position.

Vice Mayor Casale suggested updating the requirements for this position to attract candidates with specific skill sets. She was concerned that from the original pool of twenty-one (21) applicants, the City was down to only (1) applicant. She suggested postponing the meeting until more qualified applicants applied.

A motion was made by Vice Mayor Casale, seconded by Commissioner Markert, to postpone the Special Meeting scheduled for October 1, 2024 at 5:00 p.m. regarding the internal auditors, allowing Mr. Moore to give a brief presentation on the internal auditor position at the 6:00 p.m. Regular City Commission Meeting.
