RESOLUTION NO. 47-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, RECOGNIZING THAT THE CITY OF DELRAY BEACH IS CONSIDERING AMENDMENTS TO THE CITY'S LAND DEVELOPMENT REGULATIONS WITH RESPECT TO AGGREGATION OF PARCELS, DEMOLITION OF BUILDINGS OR FACADES, AND ARCHITECTURAL STYLE CHANGES ON CERTAIN PROPERTIES ZONED CENTRAL BUSINESS DISTRICT LOCATED ALONG EAST ATLANTIC AVENUE AS PARTICULARLY DESCRIBED HEREIN: PROVIDING DURING THE PENDENCY OF THE CITY'S CONSIDERATION OF THE NEW LDR AMENDMENTS, THE CITY WILL DEFER THE PROCESSING AND APPROVAL OF ALL APPLICATIONS PROPOSING TO AGGREGATE PARCELS, DEMOLISH BUILDINGS OR FACADES, OR CHANGE THE ARCHITECTURAL STYLE OF A BUILDING LOCATED ON PROPERTIES ALONG EAST ATLANTIC AVENUE AS MORE PARTICULARLY DESCRIBED HEREIN: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Delray Beach, Florida ("City") has been actively engaged in the process of undertaking a review and update of the existing Land Development Regulations (LDR) with respect to regulations regarding aggregation of parcels, demolition of buildings or facades, or architectural style changes to buildings on properties generally located along East Atlantic Avenue ("Properties"), as more particularly described in Exhibit "A"; and

WHEREAS, the City is conducting a review of the subject matter and its LDR with respect to adopting the appropriate regulations and zoning rules to the existing LDR; and

WHEREAS, in accordance with these considerations, the City of Delray Beach Department of Development Services will be proposing amendments to the City's LDR with respect to this subject matter; and

WHEREAS, multiple public meetings have been held in 2023 and 2024 to discuss potential changes to the LDR for the Properties; and

WHEREAS, on February 11, 2025, the City Commission of Delray Beach held a workshop to discuss potential changes to the LDR for the Properties; and

WHEREAS, on February 18, 2025, the City Commission directed staff to commence its review of these LDR in order to propose recommendations at a future date; and

WHEREAS, all persons or entities that desire to submit an application with respect to aggregation of parcels, demolition of buildings or facades, or architectural style changes to buildings on the Properties are on notice that the City is considering the adoption of amended LDR with respect to this subject matter, and that this subject matter should be considered zoning in progress.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. The recitals above are true and correct and incorporated into the findings of this Resolution as if set forth in full herein.

Section 2. Zoning in Progress. Pursuant to the pending ordinance doctrine and Florida law, the City Commission hereby acknowledges that the City of Delray Beach commenced preparing and considering the adoption of ordinance amendments to the LDRs with respect to establishing limitations on parcel aggregation, the demolition of buildings and facades, and changes to the architectural style of buildings on the Properties.

<u>Section 3</u>. The City's consideration of amendments to the LDR for this subject matter constitutes zoning in progress.

Section 4. The acceptance and processing of applications, permits, or any other approvals shall be deferred from consideration by the City until the end of the zoning in progress as set forth in Section 5 below for developments subject to LDR Section 4.4.13 that propose to (1) aggregate more than one parcel into a unified development, (2) demolish a building or building façade, or (3) change the architectural style of a building for the Properties as depicted in "Exhibit A".

Section 5. This zoning in progress shall remain in effect until new or amended LDR are adopted by the City Commission with respect to this subject matter or until the passage of 180 days, whichever occurs first. This policy may be extended by Resolution of the City Commission for additional periods of time in order to complete the tasks outlined herein.

<u>Section 6.</u> That this Resolution shall become effective immediately upon its passage.


