A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH AL PACKER, INC. FOR OEM AUTOMOTIVE PARTS AND SUPPLIES UTILIZING SOURCEWELL RFP NO. 080124; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, Sourcewell administers a Cooperative Purchasing Program wherein it performs the solicitation for a multitude of products and administers the resulting contracts, and

WHEREAS, contracts solicited by Sourcewell are accessible to federal, state/province, and municipal governmental entities, higher education, K-12 education, nonprofit, tribal government, and other public entities located in the United States and Canada; and

WHEREAS, Sourcewell issued Request For Proposals (RFP) 080124 to obtain vendors for original equipment automotive parts and supplies for itself and participating entities; and

WHEREAS, Ford Motor Company was awarded one of the contracts, Contract No. 080124-FMC, pursuant to the solicitation; and

WHEREAS, in accordance with the solicitation, awarded vendors are permitted to provide the OEM parts through authorized local distributor; and

WHEREAS, Al Packer, Inc. ("Contractor") is a local authorized distributor of Ford Motor Company; and

WHEREAS, the City desires to enter into an Agreement with Contractor for original equipment manufacturer automotive parts and supplies utilizing the pricing of the Sourcewell Contract No. 080124-FMC; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:
