

RESOLUTION NO. 119-26

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, RENAMING MULTIPLE PRIVATE RIGHTS OF WAY WITHIN THE LUCAYA DELRAY NEIGHBORHOOD, AS MORE PARTICULARLY DESCRIBED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City Commission of the City of Delray Beach, Florida (the “City”) has the authority to determine the final designation of names for streets, alleys, or other pathways providing access for either vehicles, bicycles, or pedestrians; and

WHEREAS, the City’s Addressing & Street Naming Manual establishes best practices for street naming; and specifically prohibits the assignment of duplicate names; and

WHEREAS, duplicate use of Catherine Drive in Lucaya Delray presents a hazard to the life, safety, and public welfare of residents in the community; and

WHEREAS, the City desires to rename segments of Catherine Drive in Lucaya Delray to support timely responses to emergency services requests; and

WHEREAS, Section 102.25 of the City Code of Ordinances states that it shall be the duty of the City Planning and Zoning Board to recommend the designation of names and numbers for streets, and it shall be the duty of the City Commission to finally determine the designation of names and numbers for streets; and

WHEREAS, pursuant to Code Section 102.25, the Planning and Zoning Board formally reviewed the request at a public hearing on July 20, 2026, and voted to recommend redesignating Catherine Drive, a private right of way, as Jayda Court; Catherine Drive, a private right of way, as Tali Trace; and Catherine Drive, a private right of way, as Emma Lane; as shown in Exhibit “A;” and

WHEREAS, the City Commission of the City of Delray Beach, deems it to be in the best interest of the City to redesignate Catherine Drive, a private right of way, as Jayda Court; Catherine Drive, a private right of way, as Tali Trace; and Catherine Drive, a private right of way, as Emma Lane.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are incorporated as if fully set forth herein.

Section 2. The existing private right of way known as Catherine Drive, and described in Exhibit “A”, is now designated as Jayda Court.

Section 3. The existing private right of way known as Catherine Drive, and described in Exhibit “A”, is now designated as Tali Trace.

Section 4. The existing private right of way known as Catherine Drive, and described in Exhibit “A”, is now designated as Emma Lane.

Section 5. This Resolution shall take effect immediately upon its adoption.
