


LEGAL DESCRIPTION:

LOT 11, BLOCK 5, TOTTERDALE ADDITION, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 23, PAGE 151 OF THHE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.

LESS AND EXCEPT A 25 FOOT RADIUS DEDICATION BEING MORE PARTIALLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE S.W. CORNER OF LOT 11 BLOCK OF THE ABOVE DESCRIBED PARCEL THENCE N $89^{\circ}42'50''$ W ALONG THE N. RIGHT-OF-WAY LINE OF N.W. 13TH STREET A DISTANCE OF 65.12 FEET TO THE POINT OF BEGINNING OF THIS DESCRIPTION ALSO BEING A POINT OF CURVATURE; THENCE CONTINUE N 89'42'50" W ALONG A TANGENT TO SAID CURVE A DISTANCE OF 24.88 FEET; THENCE NORTH ALONG A TANGENT TO SAID CURVE A DISTANCE OF 24.88 FEET TO A POINT OF TANGENCY; THENCE SOUTHEASTERLY ALONG THE ARC OF A CIRCULAR CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 25.00 FEET THROUGH A CENTRAL ANGLE OF 89°42'50" AN ARC DISTANCE OF 39.15 FEET TO THE POINT OF BEGINNING OF THIS DESCRIPTION.
