Hassan Hadjimiry, Director of Utilities, introduced Dr. Joseph Ladapo, the Surgeon General of Health for the State of Florida. Dr. Ladapo discussed the future of fluoridating the City's drinking water in light of the construction of the new Water Treatment Plant. He shared the latest findings from the National Toxicology Department regarding water fluoridation, which have indicated potential neurotoxic harm to individuals, particularly children and pregnant women, who consume fluoridated water. Dr. Ladapo stated that since fluoride became available in toothpaste and mouthwash in 1975, his recommendation would be to discontinue fluoridating the drinking water.

Mayor Carney opened the floor to anyone who wished to speak on this item.

Dr. Jeffrey Ganeles, 2365 NW 46th Street, Boca Raton
Mentioned he has an extensive 35-year career in periodontal care and education. He emphasized the importance of growing up with fluoridated water, which contributes to healthier teeth and fewer cavities in adulthood. Dr. Ganeles proposed hosting a workshop to discuss further findings and suggested reaching out to other dental publications for their input.

Dr. Richard Kitt, 6100 Glades Road, Boca Raton
Referenced recent publications recommending that fluoridation should continue in the water supply, particularly for underprivileged communities.

Angela Hill, 1103 NW 3rd Terrace, Delray Beach
Preferred to obtain fluoride from toothpaste and mouthwash for her family.

Dr. Bruce Tandy, 100 Macfarlane Drive, Delray Beach
Teaches dentistry at Nova University and practices charity dental work.

Stated that after 30 years of dental practice, he has observed a noteworthy difference in patient outcomes between those consuming fluoride and those using unfluoridated water. He mentioned his concerns that removing fluoride from the water supply would lead to an increased need for dental specialists, thereby putting more strain on patients.

Jean Marie Nacer, (registered nurse) 9473 Glider Way, Boca Raton
Stated each individual should have a choice regarding fluoride intake, and adding it to the water supply removes that choice.

Seeing no one else present, Mayor Carney closed public comments.

Discussion ensued with the Commission concerning this matter.

Deputy Vice Mayor Long acknowledged the overwhelming information on this topic but stated that he would support a "yes" vote that evening.

Commissioner Burns stated she conducted a survey, revealing most individuals oppose having fluoride forced upon them in their water.

Vice Mayor Casale acknowledged that over the past 25 years, numerous studies have supported the addition of fluoride to drinking water, along with endorsements from various health organizations. She expressed a desire to see more recent data before considering a vote against adding fluoride to the water.

Dr. Ladapo advised that disregarding warnings about fluoride levels in drinking water was irresponsible, according to the evidence.

Commissioner Markert suggested holding a workshop on this issue due to significant division among the City Commission.

Mayor Carney expressed his discomfort with mandating fluoride for those who can access it through other means, such as toothpaste and mouthwash.

The Commission thanked Dr. Lapado for his efforts and for coming to Delray Beach.

A motion was made by Commissioner Burns, seconded by Vice-Mayor Casale, to eliminate fluoride in the City's water. The motion carried by the following vote:

Amy Alvarez, entered File No. 2024-232 into the record.

Mr. Schiller, attorney for the applicant (Calabash Gunite Inc.), stated he was present to request the Commission to uphold the Planning and Zoning Board's approval of 4-1 for this item, located at 135 North Congress Avenue. This product is similar to the wholesaling and distribution of final products made from ceramics and plaster, a use that is permitted in the Mixed Use Commercial (MIC) District. He noted this project would not appear as an appealable item on a future agenda.

Julian Gdaniec, Senior Planner, provided a staff report on this item. He stated that if the Commission approved this item, a gunite yard would be permitted throughout the entire MIC District, not just at this location.

Mayor Carney opened the floor to anyone who wished to speak on this item. Seeing no one present, Mayor Carney closed the floor.

There was no cross-examination or rebuttal from either side.

The Commission engaged in a discussion on how to proceed if they decide to uphold the Planning and Zoning Board's decision.

- Inquired about a stacking lane near Unity School during the construction of Swinton Avenue.

Commissioner Burns:

- Commended the Police Department for the Bi-Low Market sting operation.
- Thanked the Finance Director for meeting with her.
- Invited the Commission and community to a meeting at the Delray Historical Society on the Civil Rights Movement in Delray Beach on February 6, 2025 @ 6:00 p.m.
- Shared a letter that she wrote regarding the conduct of the Commission.

Commissioner Markert:

- Thanked Police Chief Martin and Police Chief Mager for their

efforts.

- Thanked Mr. Moore for allowing American Heritage students to spend a day at City Hall to observe the functions of each department.

Mayor Carney:
