The Palm Beach County Traffic Division has reviewed the above referenced project Traffic Impact Statement, dated December 14, 2022, pursuant to the Traffic Performance Standards in Article 12 of the Palm Beach County Unified Land Development Code (ULDC). The project is summarized as follows:

Proposed Uses:	Modify existing uses to consist of the following: Quality Restaurant = 32,243 SF Gen. Office = 5,000 SF Gen. Retail = 14,067 SF
Project Daily Trips:	1,930
Project Peak Hour Trips:	29 (19/10) AM; 178 (111/67) PM
New Daily Trips:	582
New Peak Hour Trips:	-10 (-9/-1) AM; 40 (33/7) PM
Build-out:	December 31, 2024

Based on our review, the Traffic Division has determined the proposed development is within the City of Delray Beach Traffic Concurrency Exception Area (TCEA); therefore, it is exempt from the TPS of Palm Beach County.

Please note the receipt of a TPS approval letter does not constitute the review and issuance of a Palm Beach County Right-of-Way (R/W) Construction Permit nor does it eliminate any requirements that may be deemed as site related. For work within Palm Beach County R/W, a detailed review of the project will be provided upon submittal for a R/W permit application. The project is required to comply with all Palm Beach County standards and may include R/W dedication.
