History of The Wellbrock House



The single-family home was constructed in the late 1930s and was designed by the first registered architect in Delray Beach, Samuel Ogren, Sr., known as the "Father of Delray Beach Architecture". He is known for many of his designs throughout historic Delray Beach, and designed more than 250 homes and buildings in the City between 1924 and 1950. Some of his most notable designs include the Sandway House, the Old School Square Gymnasium, the Arcade Building, and the villas in the Marina District.

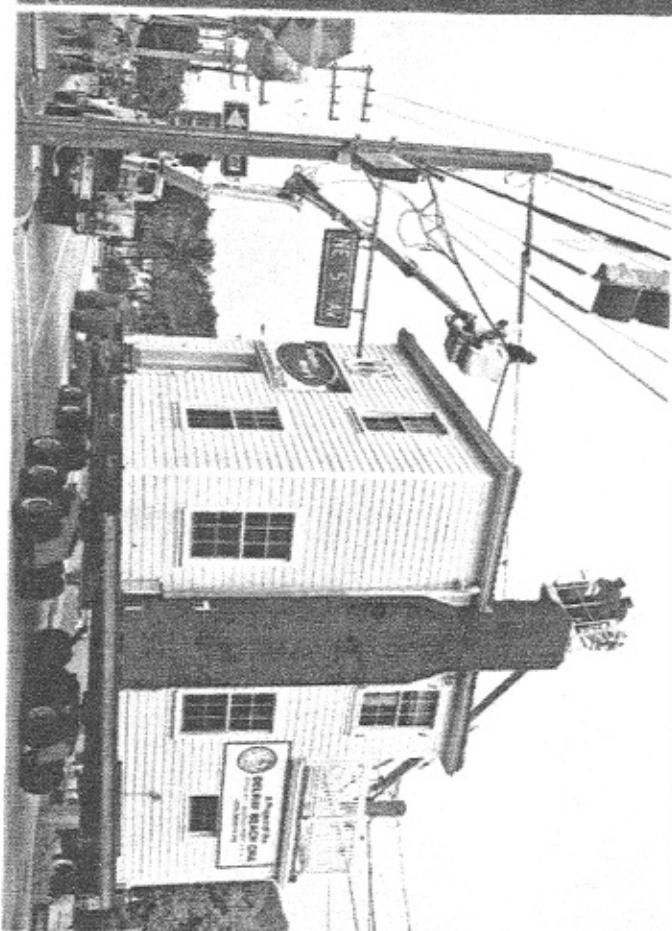

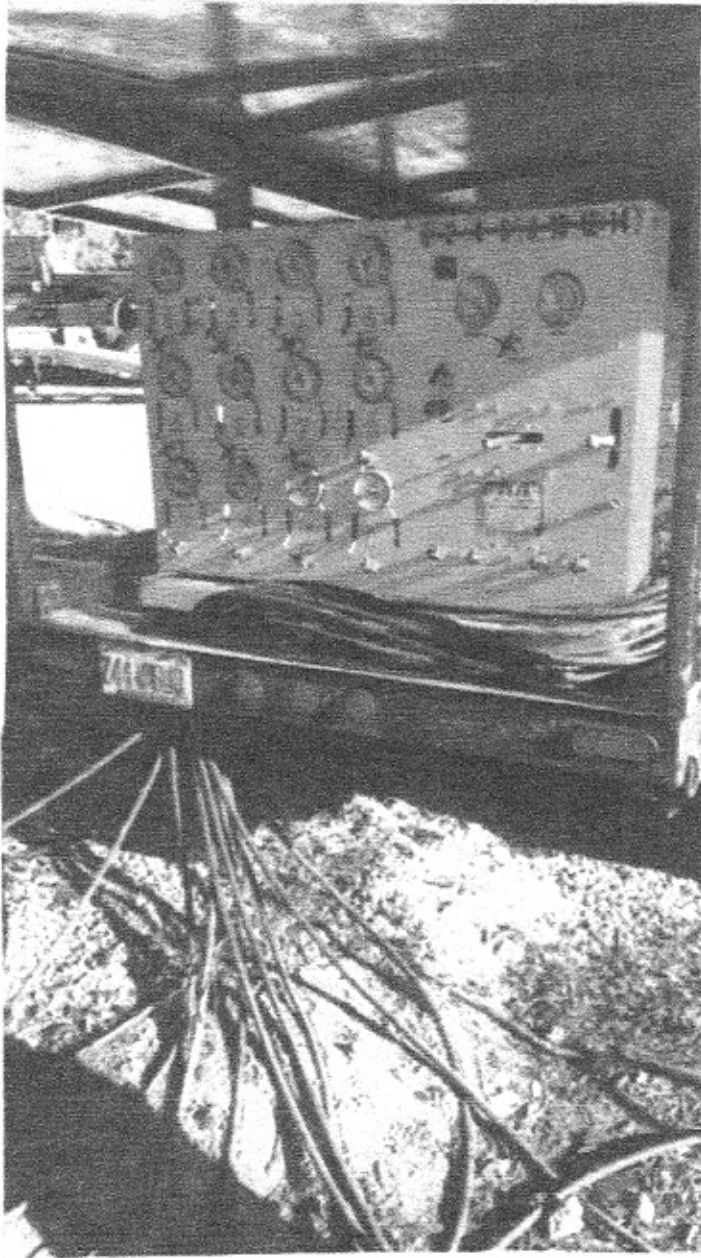

Our method for relocating or raising structures is the tried and true method of steel beams, unified jacking system, and cribbing to secure the structure until the new foundation is constructed. We shall place multiple steel beams beneath the structure, hydraulically load the structure onto the steel beams, then elevate the structure to the elevation required to install the helical pilings. Once the pilings are installed and the new footings are poured, we lower the structure to allow the concrete stem wall to be constructed, then place the structure onto the new wall.



We also were contracted to move the 2 story garage apartment that went with the house. It was of the same construction and built at the same time. It was to move along with the house, bringing up the rear. The two single car garage doors were supported with a column in the middle. We used the same method for that column that we used on the portico columns, with success as well. The 2 car garage apartment was to be repurposed into office space for the restaurant, which the house was destined to become, and a bar. So, all was not lost on the adult beverage front. Alcohol, of course, being the cause and remedy to all life's defects.

We had a nice working area on the original location, so we loaded the house from the rear, spun the house 180 degrees so we could pull into the new location at the park, where space was more limited. With 9 dollies under the house and (2) 2 axle and (2) 3 axle dollies under the 103 ton 2 story garage apart-

ment, we needed some additional, experienced equipment on the ground. We received much appreciated help from Tom and Randy Youngblood and their crew from Sanford as well as Keith Kleppinger of Rust Building Movers of Miami. Tom also brought his 4 toCar Winch Truck which deemed the operation to be letproof.

Moving day was Sunday, March 1, 2020, a typical winter day. Sunny and 70 degrees. Perfect for house move and hundreds of spectators lining the 3/10 of a mile route.

Atlantic Avenue is a 6 lane road with an 8' landscaped median. Our dollies were set on 25' centers so we straddled the median and all the vegetation save 2 coconut palm trees which were removed minutes before we arrived at their location and replanted minutes after we passed their location. Palm trees never knew it happened.
