TECHNICAL APPROACH, AVAILABILITY AND SCHEDULING

A. How will we meet the city requirements:

We have been providing safety shoes to the City of Delray for many years. We have two locations one in West Palm Beach and one in Margate Florida. Also, we have two shoe trucks.

B. Benefit the City and their employees:

We have over 8000 pr of Safety shoes combined in both store and trucks.

We also have a new AI fitting computer that assures proper fit in both stores, With sizes for 6 to 16 and widths from narrow to extra wide.

C. Ample inventory:

The main factories in Red Wing Minnesota where we can get inventory within a week to 10 days. Red Wing also has about 700 stores throughout the county that we can get shoes from also.

D. How city employees will view, review and select safety shoes:

We have display set up in both stores and both trucks to show what styles we have available in their price range.

E. Employees sales ticket:

A sample will be provided.

F. Billing approach:

We will send out bill as often as you would like i.e. daily, weekly, monthly.

G. Sample of monthly invoice:

Sample will be provided.

H. Instructions on how shoes would be returned and replaced if defective:

The defective shoe will be brought back to the store or the truck and exchange would be made to the defective footwear there.

I. How tracked and warranty is handled:

We keep a history/record of every customer. Date, style, size.

J. Team's availability:

The store are open from 10-7 Monday to Friday and 10-5 on Saturday. Also we are open on Sunday from 12-4. Right now we go to Delray the second Tuesday of every month.

K. Description of the mobile units:

Both truck hold up to about 1000 pr of footwear, can it up to 4 employees at a time. A picture is enclosed.

L. Ordering Forms:

Challenges & Lessons Learned

As a Red Wing Shoe store, we represent a brand that has been a leader in safety footwear for 125 years, with our West Palm Beach location serving the community under the same ownership for over 41 years. Longevity, however, does not come without challenges. One of the greatest challenges we have faced is adapting to rapid changes in technology while continuing to provide the personalized service our customers expect.

For example, Red Wing was initially slow to enter the digital marketplace. This created challenges in meeting the expectations of clients who wanted online accessibility in addition to in-store service. To overcome this, we worked closely with Red Wing corporate initiatives, embracing new systems such as the AI-based point-of-sale system introduced in 2025. We also prepared our team to integrate future tools like account-based online sales, ensuring we can serve both traditional and modern client needs. The lesson we learned is that adaptability and communication are key. By staying proactive, training our staff thoroughly, and embracing change rather than resisting it, we've been able to strengthen client relationships and deliver consistent service even as the industry evolves.

Another major challenge we have faced is **invoicing and account management**. Accuracy in setting up client profiles on the back end is critical to ensure invoices are delivered on time, to the correct location, and reflect each account's requirements. Each account profile must be tied to its own approved price list, ensuring that when employees come in to be fitted, only authorized footwear is accessible through the POS system. Additionally, account managers must be familiar with Red Wing's procedures for handling incorrect invoices, defective shoes, and credits. Since invoicing is handled through Red Wing corporate rather than directly at the store, our role as the middleman requires close coordination, attention to detail, and proactive communication with clients.

The lesson we have learned from this process is that **clear setup, ongoing training, and transparent communication prevent billing and account disruptions**. By investing time upfront to ensure profiles are accurate and keeping clients informed of procedures, we minimize errors and deliver a smooth experience for both managers and employees.
