Consider a recommendation to approve Bid No. 2014-42, "Electrical Services and Repairs" to Imperial Electric as the primary contractor, and also to Universal Electric of Florida for the secondary/back up contractor; with a not to exceed annual expenditure limit of \$25,000 between the two (2) contractors. Two (2) contractors have been awarded the electrical contract in the past due to there are circumstances where one of the contractors may be busy and cannot respond.

The Electrical Services and Repairs contract was bid again this year by the City's Purchasing Department using a sealed competitive bid process (Bid No. 2014-42.) The contract is for one (1) year, with two (2) consecutive renewals of one (1) year each with the approval of the City Commission.

Attached is the bid tabulation that provides a comparison of the unit costs. Please note that the bid is structured at a fixed hourly rate (and the number of hours is estimated). See below for expenditures:

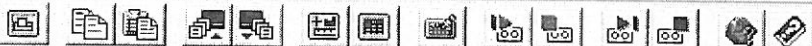

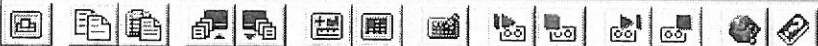
