## CITY OF DELRAY BEACH AMENDMENT NO. 1 TO AGREEMENT RFQ 2021-005 CONSTRUCTION ENGINEERING AND INSPECTION SERVICES FOR RECLAIMED WATERMAIN FOR AREA 10.

THIS AMENDMENT NO. 1 to Agreement RFQ 2021-005 Construction Engineering and Inspection Services for Reclaimed Watermain for Area 10, dated March 8, 2021, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and CHA Consulting Inc., formerly known as A&P Consulting Transportation Engineers Corporation (hereinafter referred to as "Contractor") a Florida corporation, is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 20 .

#### WITNESSETH:

WHEREAS, on March 8, 2021, the City entered into an agreement with Contractor for Construction Engineering and Inspections Services for Reclaimed Watermain Area 10 (hereinafter referred to as the "Agreement"); and

WHEREAS, on June 24, 2022, the City added additional spending to the Agreement with Contractor to include additional CEI Professional Services in the amount of \$59,328; and

WHEREAS, the City desires to amend the Agreement to add additional Construction engineering and Inspections Services in the amount of \$18,464 for a total estimated amount of \$201,814 as stated in Composite Exhibit "A"; attached hereto and incorporated herein; and

WHEREAS, the parties seek to amend the Agreement to extend the Agreement for an additional six weeks; and

WHEREAS, Contractor agrees to continue to provide services to the City in accordance with the terms and conditions of the Agreement.

**NOW, THEREFORE**, in consideration of the mutual promises contained herein and other good and valuable consideration of which the parties hereto acknowledge, the parties agree as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. The Agreement is hereby amended to replace the original scope of services with a new scope of services attached hereto as Exhibit "A" to add additional construction engineering and inspection services to the Agreement and to extend the Agreement for an additional six weeks.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
