

RESOLUTION NO. 06-26

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF A PURCHASE ORDER TO TEN-8 FIRE & SAFETY, LLC; UTILIZING FLORIDA SHERIFFS ASSOCIATION CONTRACT NO. FSA25-VEF19.0 FOR THE PURCHASE OF A NEW FIRE RESCUE AMBULANCE AND EQUIPMENT; AUTHORIZING THE CITY MANAGER TO ISSUE THE PURCHASE ORDER AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff’s Association (FSA) administers a cooperative purchasing program wherein it performs solicitations for a multitude of products and administers resulting contracts; and

WHEREAS, contracts solicited by FSA are accessible to FSA members, and municipal government entities, political subdivisions, or agencies of the State of Florida; and

WHEREAS, FSA issued Solicitation FSA25-VEF19.0 to obtain vendors for Fire & Rescue Vehicles, Boats & Equipment; and

WHEREAS, Ten-8 Fire & Safety, LLC is one of the authorized dealers awarded the contract under FSA No. FSA25-VEFL9.0; and

WHEREAS, the City desires to issue a purchase order to Ten-8 Fire & Safety, LLC for the purchase of one (1) 2027 Braun Super Chief Ambulance and equipment utilizing the same terms, conditions, and pricing under Solicitation No. FSA25-VEFL9.0; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach hereby approves the issuance of a purchase order to Ten-8 Fire & Safety, LLC, utilizing FSA Contract No. FSA25-VEF19.0 for the purchase of one (1) 2027 Braun Super Chief Ambulance and equipment, as described in the Equipment Proposal attached hereto as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to issue a purchase order and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon its passage and adoption.
