AN ORDINANCE OF THE CITY COMMIS-SION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING THE LAND DEVEL-OPMENT REGULATIONS OF THE CITY OF DELRAY BEACH CODE OF ORDINANCES; PROVIDING CHAPTER 4, "ZONING REGULATIONS," ARTICLE 4.3, "DISTRICT REGULATIONS, GENERAL PROVISIONS, SECTION 4.3.4, "BASE DISTRICT DEVELOP-MENT STANDARDS," SUBSECTION (H), "SETBACKS," BY AMENDING SUBSEC-TION (4), "STRUCTURES ALLOWED IN SETBACKS," TO AMEND THE TITLE AND MODIFY THE BUILDING ELEMENTS AND SITE IMPROVEMENTS PERMITTED WITHIN REQUIRED BUILDING SETBACKS; AMEND-ING CHAPTER 4, "ZONING REGULATIONS," ARTICLE 4.6, "SUPPLEMENTAL DISTRICT REGULATIONS," SECTION 4.6.15, "SWIM-MING POOL, WHIRLPOOLS, AND SPAS," FOR CONSISTENCY WITH EDITS TO SEC-TION 4.3.4(H); AND AMENDING APPENDIX A, "DEFINITIONS," TO ADOPT A DEFINI-TION FOR BAY WINDOW, PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AUTHORITY TO CODIFY, PROVID-ING AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.
