RESOLUTION NO. 45-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AUTHORIZING A SPECIAL EVENT SPONSORSHIP IN AN AMOUNT NOT TO EXCEED \$8,000 FOR THE SPECIAL EVENT KNOWN AS THE 4TH ANNUAL DELRAY BEACH CONCOURS D'ELEGANCE TO BE HELD ON APRIL 27, 2025; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City Commission desires to sponsor special events in the City of Delray Beach ("City") that provide a public purpose in alignment with the City's Special Events Policy; and

WHEREAS, the City received a Special Event Sponsorship Request from the Delray Concours Foundation (the "Applicant") requesting the City to sponsor the 4th Annual Delray Beach Concours d'Elegance (the "Special Event") to be held on April 27, 2025 on and around the Old School Square Campus; and

WHEREAS, the Applicant has requested a waiver of costs related to the provision of City services for the event minus any direct costs to the City, in an amount not to exceed \$8,000; and

WHEREAS, the Applicant provided a Statement of Public Purpose, attached hereto and incorporated herein as Exhibit "A", which anticipates a profit in the amount of \$64,000 to be donated in five parts to the Delray Beach-based non-profit organizations: the Charlie Fund, Delray Citizens for Delray Police, Delray Fire Benevolent, the Community Classroom Project and the Achievement Center; and

WHEREAS, the City Commission has reviewed the Special Event Sponsorship Request application and considered whether the Special Event will provide a public purpose that is in alignment with the Special Events Policy.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are incorporated as if fully set forth herein.

Section 2. The City Commission has considered the Special Event Sponsorship Request application and finds that the 4 th Annual Delray Beach Concours d'Elegance to be held on April 27, 2025 provides a public benefit consistent with the City's Special Event Policy.	
Section 3. The City Commission approves the Delray Concours Foundation in an amount not to exceed \$8,	he request for sponsorship submitted by ,000.
Section 4. The City Commission authorizes the City Manager to execute an agreement consistent with the approval herein and to take any and all actions necessary to effectuate the intent of this Resolution.	
Section 5. This Resolution shall take effect imme	ediately upon its adoption.
