AMENDING THE CODE OF ORDINANCES BY AMENDING TITLE 5, "PUBLIC WORKS," CHAPTER 52, "WATER," SECTION 52.34, "WATER RATES," TO INCREASE THE RATES FOR WATER FURNISHED BY THE CITY; AND AMENDING CHAPTER 53, "SANITARY SEWERS," SECTION 53.130,

In accordance with the provisions of controlling law, the City of Delray Beach hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

The proposed ordinance will establish a strong financial foundation for securing a revenue bond to fund the construction of a state-of-the-art nanofiltration water treatment plant. This new facility will significantly enhance water quality for the more than 72,000 residents of the City of Delray Beach, providing safer and cleaner drinking water. Designed to meet the latest Environmental Protection Agency (EPA) standards, the plant will effectively address emerging water quality concerns, including the removal of per- and polyfluoroalkyl substances (PFAS), commonly known as "forever chemicals." By ensuring compliance with the EPA's upcoming Maximum Contaminant Levels (MCL), this investment will safeguard public health, support regulatory compliance, and secure a sustainable and reliable water supply for future generations.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Delray Beach, if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
- (b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and
- (c) An estimate of the City of Delray Beach's regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

(a) Under the current water and sewer rate structure, customers' bills were already expected to increase by approximately 4.5% as part of the previously approved rate adjustment implemented in July 2022. The newly adjusted rate will add an additional 5% to that increase, bringing the total adjustment to 9.5% for a typical average \$400 monthly water and wastewater sewer bill. As a result, for estimated 2,744 commercial customers, the combined impact of these adjustments will lead to an estimated monthly increase of \$104,300.
