

RESOLUTION NO. 05-26

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH MOTION INDUSTRIES, INC. DBA HYDRAULIC SUPPLY CO., TO PURCHASE HYDRAULIC HOSES AND REPAIRS FOR HEAVY DUTY TRUCKS AND EQUIPMENT UTILIZING THE CITY OF BOCA RATON INVITATION TO BID (ITB) 2022-054; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires hydraulic hoses and repairs for heavy duty trucks and equipment; and

WHEREAS, the City of Boca Raton issued Invitation to Bid (the “ITB) 2022-054 to obtain hoses and repairs for heavy duty trucks and equipment; and

WHEREAS, in accordance with ITB 2022-054, the City of Boca Raton entered into an agreement with Motion Industries, Inc. dba Hydraulic Supply Co. (“Contractor”); and

WHEREAS, the City desires to obtain these aforementioned services by utilizing an existing Agreement with Contractor pursuant to the City of Boca Raton ITB 2022-054; and

WHEREAS, in accordance with Section 25 of the City’s Purchasing Policies and Procedures Manual, piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Contractor, which is attached to this Resolution as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to execute any amendments and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
