I. CALL TO ORDER

The meeting was called to order by Chair Jose Aguila at 6:02 P.M.

II. ROLL CALL

V. COMMENTS FROM THE PUBLIC

Bob Ganger, Florida Coalition – At your last meeting you made a decision on Atlantic Crossing with respect to the ingress and egress options. That decision can be appealed. I can find no record of anyone appealing it. But there is a commission meeting coming up next Tuesday and there is no agenda for the meeting and there is no way that I can figure out whether or not anyone has appealed your decision or not. So I'm asking the question because I would think you would know if your decision was being appealed.

Jose Aguila – I've heard nothing of that fact.

Janice Rustin – We haven't received anything at the City Attorney's office at this time.

Bob Ganger – So, for the record, there is no appeal of your decision?

Jose Aguila – Not that we are aware of.

Bruce Leiner, President of Harbour House Homeowners Association – As of 5 p.m. today, I was upstairs and they knew nothing about an appeal. I called the City Attorney's office and was told the same thing. I heard from others that they were planning to appeal, and I am going to be out of town next week and I wanted to, obviously, have Party Status and be able to speak if the decision is overturned. I just want to know if they have missed that deadline.

The handout that you have is very important and I wanted to clarify what I testified to last time I was before you. If you look at the location map, this is from Delray Beach City. It's showing the actual state of the surrounding properties and the room that I told you has never abandoned, it clearly earmarked as that is the truth. You see Atlantic Court directly in the circle. This is what is physically platted and what they are looking to have and need to have abandoned, and yet that meeting have never occurred. Secondarily, while we are actually in favor of remodeling and we are in favor of this restaurant, you can see in this little small circle where 7th Avenue intersects this property, if you don't have that reliever road to Federal Highway, basically that 1,000 cars, 500 cars in and out, will heading down 7th into 1st, right past this property you are about to approve, I hope. So I thought that was relevant and I thought you should know about it.

Jim Knight - I don't have any problems with it.

Roger Cope – I totally agree with staff.

Vlad Dumitrescu – I agree but think they should center the "Home of the Whopper".

Jose Aguila – I think their request is legitimate. Unless you know they are there, you cannot see that they are there. We've done this in very similar, previous conditions. So I think for consistency and the fact that it is so internalized, I'm perfectly okay with the request. I agree with Vlad that "Home of the Whopper" should be centered.
