6. PRESENTATIONS

June 4th, 2024, City Commission Meeting Presentation Review

Janai Bowens reviewed the presentation for the June 4th, 2024, Delray Beach City Commission meeting. **Janai** indicated that the presentation will be a collaborative effort between herself and **Dr. Raiko Knight**, Education Board Chair. Janai stated the purpose of the presentation will be to inform the City Commission and public of the status of Delray Beach Public Schools, propose direction regarding staff and Education Board priorities, provide clarification regarding school funding, and to seek clarity regarding the Education Board's composition and ordinance.

Dr. Raiko Knight reviewed the proposed goals of the Education Board that will be presented during the City Commission meeting. **Dr. Knight** will suggest that the City Commission consider appointing Education Board members that hold specific professional expertise to build a composition of all necessary stakeholders.

Kae Jonsons questioned the need for the Education Board composition to be revisited. She also stated that the City of Delray Beach Comprehensive Plan should be used to determine the goals and priorities of the Board and used as a roadmap for future program planning. Janai stated the point of including the ordinance was to allow the new City Commission to provide direction on the future of the board's scope and size.

Janai Bowens stated that the new document included proposed objectives that aligned with each priority previously drafted by **Marjorie Waldo** on behalf of the Education Board. The Education Board reviewed the document and did not provide suggestions for changes.
