

RESOLUTION NO. 2026 - 11
A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF THE DELRAY BEACH COMMUNITY
REDEVELOPMENT AGENCY APPROVING AND
AUTHORIZING THE OBSERVATION OF FLORIDA
REDEVELOPMENT WEEK FROM SEPTEMBER 14-18,
2026; PROVIDING FOR CONFLICTS; PROVIDING FOR
SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Community Redevelopment Agencies have a vital role in revitalizing neighborhoods, addressing areas of slum and blight, strengthening local economies, revitalizing downtowns, and improving the quality of life for residents and businesses throughout the State of Florida; and

WHEREAS, the Florida Redevelopment Association (“FRA”), in partnership with municipalities, counties, and community stakeholders, promotes best practices, professional education, and collaboration to advance community redevelopment efforts throughout Florida; and

WHEREAS, *Florida Redevelopment Week* from September 14 -18, 2026 serves as an opportunity to recognize redevelopment achievements, highlight transformational projects, engage residents and stakeholders, and celebrate the economic, social, and cultural benefits of community revitalization; and

WHEREAS, the Delray Beach Community Redevelopment Agency (“CRA”) was created on June 18, 1985, by the Delray Beach City Commission to aid in eliminating slum and blight in the City of Delray Beach (“City”); and

WHEREAS, the CRA has endeavored towards its mission of eliminating slum and blight in part through the purchasing of land for the purpose of developing affordable housing, investing in infrastructure improvements, helping to revitalize local commercial districts like the CRA redevelopment of 98 NW 5th Avenue, and many other impactful projects and initiatives; and

WHEREAS, the CRA has amended the CRA Plan this year, subject to City approval, reaffirming its commitment to the CRA mission and the future of community redevelopment; and

WHEREAS, the Board deems it to be in the best interests of the CRA to approve the observation of Florida Redevelopment Week from September 14 -18, 2026.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY AS FOLLOWS:

Section 1. The foregoing “WHEREAS” clause is hereby ratified and confirmed as being true and correct and is hereby incorporated herein.

Section 2. The Board of Commissioners of the Delray Beach Community Redevelopment Agency hereby approves and authorizes the observation of *Florida Redevelopment Week* from September 14 -18, 2026.

Section 3. All resolutions inconsistent or in conflict herewith shall be and are hereby repealed insofar as there is conflict or inconsistency.

Section 4. If any section, sentence, clause, or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction then said holding shall in no way affect the validity of the remaining portions of this Resolution.

Section 5. This resolution shall become effective upon its passage and adoption by the City of Delray Beach Community Redevelopment Agency Board of Commissioners.
