For the past 35 years, I have lived as a recovering addict and an actively engaged member of Narcotics Anonymous, which has given me firsthand experience in recovery work

I have been a community activist in the city of Delray Beach for over 35 years. My initial involvement began with the creation of a grassroots organization called "MAD DADS," which mobilized a group of recovering addicts to reclaim our neighborhood from the crack wars of the 1980s and 1990s. This work led to the establishment of the Delray Beach Drug Task Force, the Delray Beach Drug Courts, 28 neighborhood associations, and Village Academy.
