A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FLORIDA. APPROVING DELRAY BEACH. А **TECHNICAL** ASSISTANCE VOUCHER APPLICATION TO THE UNITED STATES DEPARTMENT OF ENERGY TO OBTAIN FEDERAL GRANT FUNDS FROM THE ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT PROGRAM TO DEVELOP EDUCATIONAL CURRICULUM FOR THE SCHOOL DISTRICT OF PALM BEACH COUNTY TO HELP PREPARE WORKERS FOR GREEN **INDUSTRIES**; JOBS IN THE CITY MANAGER TO EXECUTE ANY AUTHORIZING AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION: PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City is implementing multiple programs and initiatives to increase sustainability and reduce energy usage; and

WHEREAS, initiatives such as workforce development for jobs in the green economy, and energy conservation planning are important aspects of becoming a more sustainable community; and

WHEREAS, the City desires to apply for technical assistance vouchers through the Department of Energy (the "DOE") to obtain federal grant funding from the Energy Efficiency and Conservation Block Grant (the "EECBG") Program; and

WHEREAS, the technical assistance vouchers are a method of exchanging an eligible entity's EECBG Program formula award for technical assistance services; and

WHEREAS, the City will use its technical assistance vouchers to develop and obtain an educational curriculum designed to help prepare workers for jobs in green industries; and

WHEREAS, the curriculum will incorporate the DOE's Justice40 initiative, established to direct resources to disadvantaged communities, and will be designed for non-college bound students; and

WHEREAS, the curriculum will be administered by the School District of Palm Beach County, Florida; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves this Application to the Technical Assistance Voucher Application, attached hereto and incorporated herein as Exhibit "A".

<u>Section 3.</u> The City Commission authorizes the City Manager to execute any amendments thereto and take any other actions necessary to effectuate the intent of this Resolution.

<u>Section 4.</u> This Resolution shall become effective immediately upon adoption.
