WARRANTY DEED

SUBJECT TO: Real Estate Taxes for the current year and subsequent years; restrictions, easements of record, and applicable zoning ordinances; all terms, provisions, conditions, and easements as set forth in the Declaration of Covenants, Restrictions and Easements for Atlantic Grove, and any amendments thereto; restrictions, rights-of-way, dedications, and other matters appearing on the Plat or otherwise common to the subdivision.

Together with all tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining; to have and to hold, the same in fee simple forever. 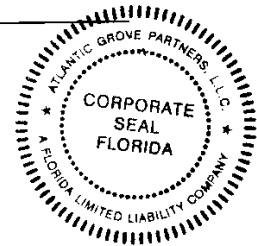
