Scott Montgomery, with Marcum LLP, provided an overview presentation on the City's annual comprehensive financial report (ACFR) for the fiscal year ending September 30, 2023. He mentioned that the financial statement included separate audits of the Downtown Development Authority and the Community Redevelopment Agency, which were

consolidated into the City's audit.
