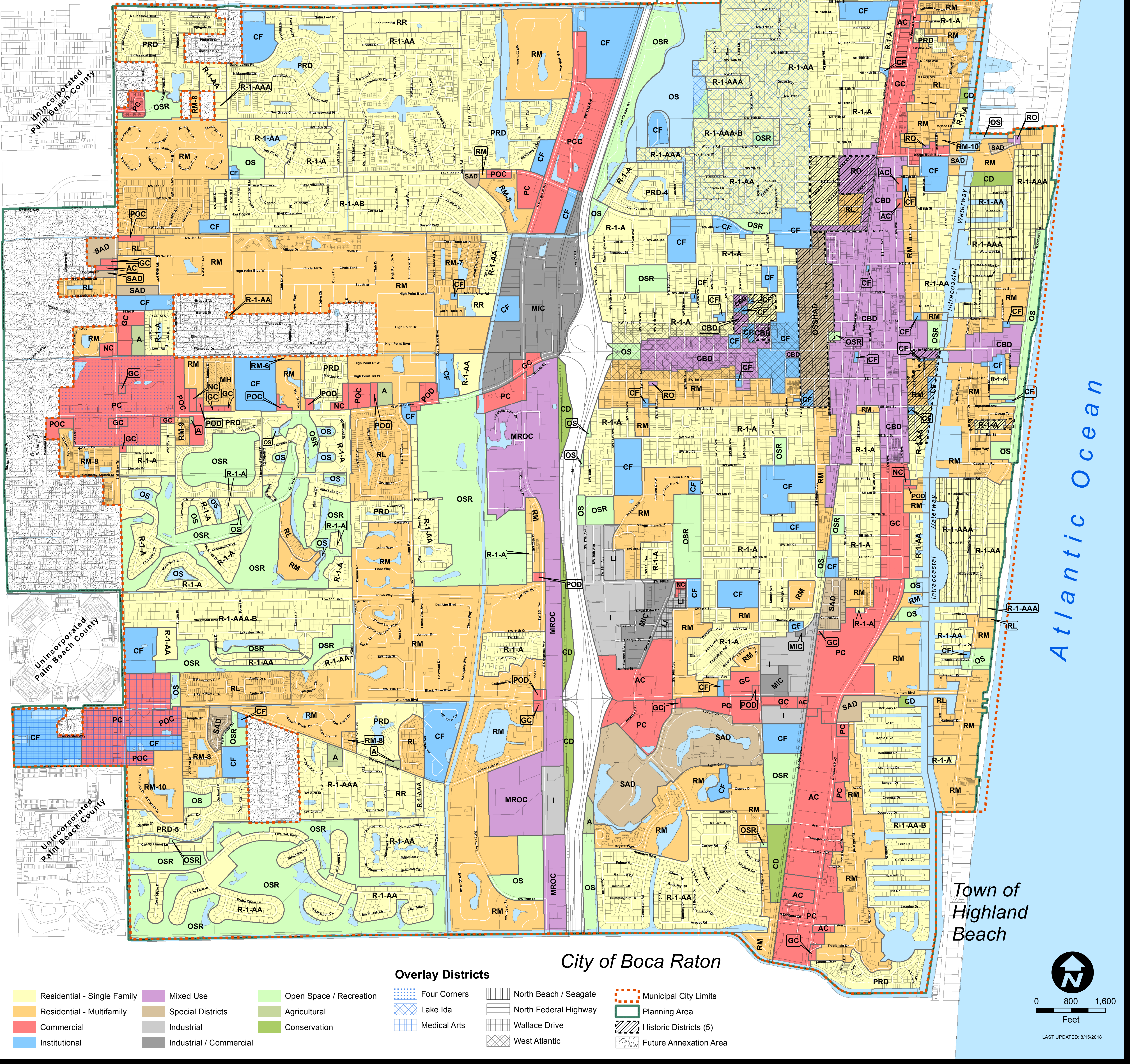




CITY OF DELRAY BEACH ZONING MAP

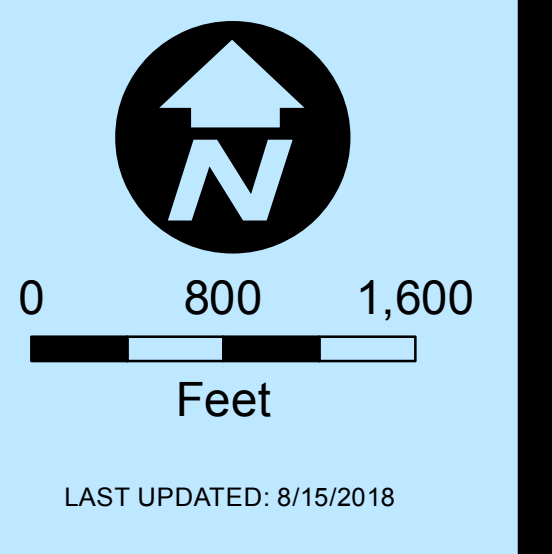
