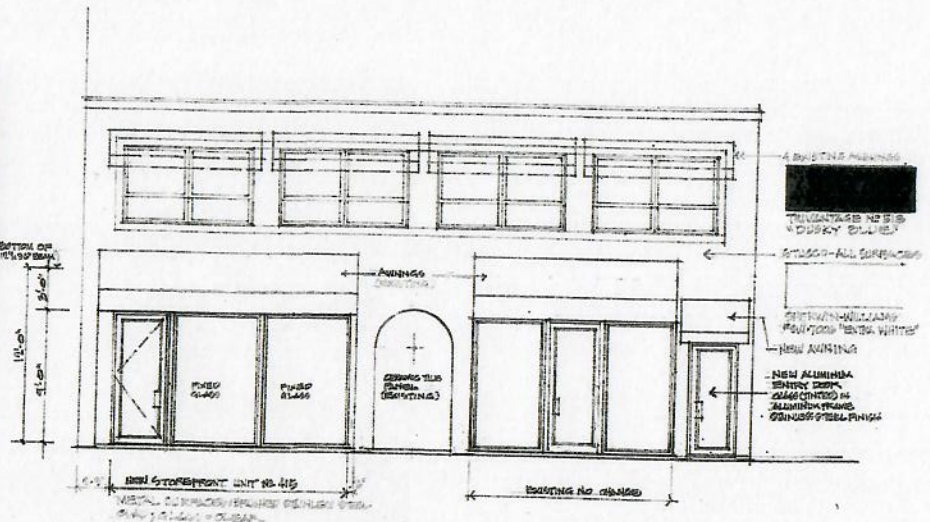
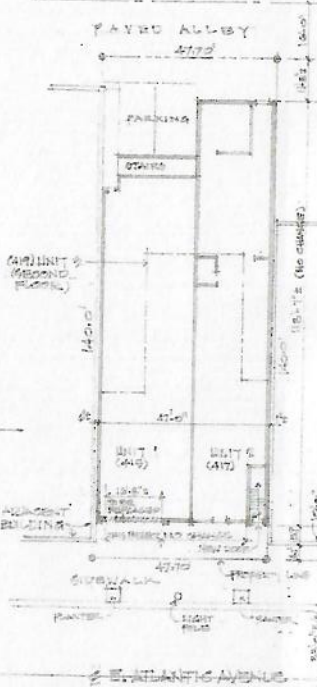
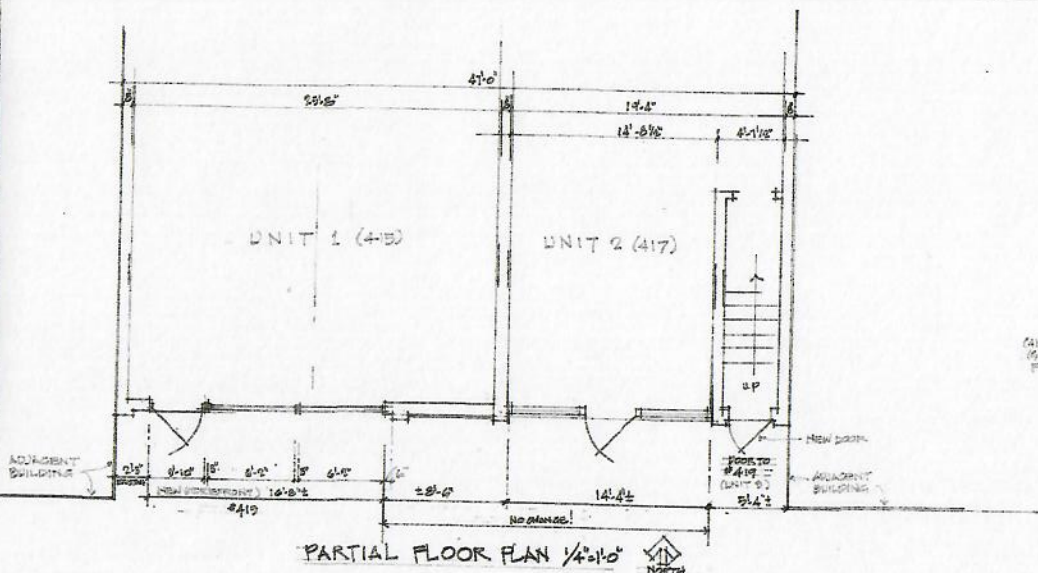


EXISTING BUILDING NO SCALE

- PROJECT DESCRIPTION**
- THE PROPOSED WORK OF THIS PROJECT INCLUDES THE FOLLOWING:
- UNIT 1 (415)
    - REMOVE EXISTING GLASS STOREFRONT, INCLUDING ENTRANCE DOOR, WINDOW AND SILL BEARING AND OTHER MORTAR STRUCTURES. PROVIDING A CLEAN EXPOSED 16" VISE BY 1/4" HIGH, AND PREPARE OPENING FOR NEW STORE FRONT INSTALLATION.
    - INSTALL NEW GLAZED ALUMINUM DOOR AND STORE FRONT, FINISHED STAINLESS STEEL TRIM, MATCHING THAT IN UNIT 2, WITH GLAZING TO BE CLEAR GLASS SHEETGLASS.
    - REPLACE EXISTING WOOD EGGS AND FRAMES WITH NEW GLAZED ALUMINUM ENTRANCE DOOR AND FRAME, COMPLETE WITH LOCKSET, CLOSER, BRUSHED STAINLESS STEEL FINISH AND TINTED GLASS.
    - PAINT THE BUILDING WITH EMERSON HOLLANDS PAINT NO. 59 TUFF EXTRA WHITE, SATIN FINISH, AND RECOVER THE SIGNAGE ARE WITH BEY-BEY VINYL MATERIAL, NO. 302 TRUCKY SLAB.
