## RESOLUTION NO. 22-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH RECHTIEN INTERNATIONAL TRUCKS, INC., AS AN APPROVED SOLE SOURCE, TO PURCHASE INTERNATIONAL MOTORS, LLC, ORIGINAL EQUIPMENT MANUFACTURER PARTS AND SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City utilizes vehicles manufactured by International Motors, LLC ("International"); and

WHEREAS, International qualifies and designates specific dealers within different regions throughout the United States for the sale of factory-authorized services and parts; and

WHEREAS, in order to preserve any warranties on the International vehicles, the City must use International original equipment manufacturer ("OEM") parts and related services to maintain and service its International vehicles; and

WHEREAS, International OEM parts and related services are provided exclusively in Florida through Rechtein International Trucks, Inc. ("Contractor"); and

WHEREAS, on October 23, 2024, in accordance with Section 38 of the City's Purchasing Policies and Procedures Manual, the Contractor was approved as a Sole Source pursuant to the Memorandum attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the City desires to enter into an agreement with the Contractor, as a Sole Source, to obtain International OEM parts and services (the "Agreement"); and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:
